Markets in Financial Instruments Directive

The Markets in Financial Instruments Directive 2004/39/EC, known as MIFID, is a European Union directive that provides harmonised regulation for Investment Services across the Member States of the European Economic Area.

MiFID objectives were, inter alia, to monitor the provision of Investment Services and Activities across Europe; to protect Investors, to offer transparency, efficiency and uniformity of financial markets, to allow the provision of services across Europe by firms authorized by corresponding home regulators and to assure best execution and internal controls.

MiFID has been repealed by the Markets in Financial Instruments Directive 2014/65/EU ("MiFID II"), which came into force on 3 January 2018. The objectives of MiFID II include, inter alia, to make European financial markets more transparent and to strengthen investor protection.

As a Cyprus Investment Firm (CIF), authorized and regulated by the Cyprus Securities and Exchange Commission under license no. 179/12, the Company complies with the Law 87(I)/2017, which incorporates MiFID II into Cyprus national law.
